**Agenda:**

**Friday: 2:00pm** Waseca County Fairgrounds will open for arrival and registration/camping.

**7:00am** Breakfast served.

**9:00am** Wagon Train to leave the Waseca County Fairgrounds, covering approximately 14 miles. We will stop for a lunch break; a box lunch will be served.

**2:30pm** (approx.) Arrive back at the Fairgrounds.

**3:30pm** Arena games in the outdoor arena for riders and nonriders! \$5 entry per person/per game with 100% of the money going to Children's Hospital. Pull up a chair and watch the fun and silliness unfold. ☺

**6:00pm** Supper served.

**7:30pm** A short Program with member posses presenting their donations to Children's Hospital.

**8:00pm** Live auction with music to follow

**9:30am** Wagon Train to leave the Waseca County Fairgrounds covering approximately 7 miles.

**11:00am** Arrive back at the fairgrounds. Clean up and depart by 3:00pm.

**Notes and Rules:**

Wagons will lead the route, with riders and saddled horses to follow the wagons. Horses, mules and ponies are welcome. MN State Law requires that all horses participating in a public event have a current Coggins test—You must have proof of negative Coggins test with you. There will be no alcohol allowed on the Wagon Train route. We recommend that horses be shod all the way around. We recommend helmets for riders under the age of 18. Any unruly horses posing a safety threat will be asked to leave; no stallions please. Some box stalls are available on a first-come, first-served basis and corrals will be allowed in the infield area; you must supply your own fencing. All horse areas must be thoroughly cleaned before you leave. Bring your own mask due to COVID restrictions!

## **2020 Wagon Trail for Youth Rules**

1. The Wagon Master is in charge and his orders will be followed.
2. A liability waiver must be signed by all participants of the Wagon Train. Please see the registration table to sign your waiver.
3. No alcoholic beverages permitted on the Wagon Train route. No disorderliness will be tolerated.
4. A team and wagon has the first right-of-way. Outriders will follow the direction of the teamster. All saddle horses will follow the wagons. No passing of a wagon will be allowed.
5. All wagons must display a slow-moving vehicle sign; it is the law.
6. No unhitching of teams or dismounting of saddle horses until the wagon train has come to a complete stop at break and stops. "Riders down" will be called by the Wagon Master.
7. No dogs will be allowed on the Wagon Train route. No stallions. No wet mares with a foal.
8. Uncontrollable animals or people will be excused from the event.
9. Yellow or red ribbons must be on the tails of all kicking animals. Ribbon will be available from the Wagon Master.
10. All participants must bring their own water bucket. Water for horses will be available at the break. Saddle horses should make arrangement to haul their bucket in a wagon.
11. Loaded firearms are not allowed on the Wagon Train route.
12. Each person is responsible for cleaning up around their camp and where their horses are kept. Dumpsters are available.
13. Horses in saddle or harness must have a responsible person present at all times.
14. Halters or neck strap **MUST** be carried with riders/teamsters at all times. No tying with reins.
16. No horses can be tied to a trailer overnight in the grass areas. Use the stalls in the designated barns or create a corral in the infield area.
16. **ALL** participants **MUST** follow the Wagon Train route; no straying off on your own.
17. Decent animal treatment and good citizenship is expected.
18. Participant horses must have current proof of negative Coggins test.

**SAFETY is the objective of all rules. All rules will be enforced.**

**Any questions of these rules should be discussed with the Wagon Master.**
